## **Fireforce Balloon Inflation Device Received Product Certificate from Thailand**

Recently, MicroPort Scientific Corporation (HK: 00853) announced that it has received official certificate of regulatory approval on Fireforce Balloon Inflation Device from Thailand's Ministry of Public Health (MOPH). The validity period is through September 16, 2014. This is the first international regulatory approval for MicroPort's Fireforce Balloon Inflation Device.

The Fireforce Balloon Inflation Device includes pressure gauge, extension tube and hand-held holder. It is a medical device intend for inflation and deflation of medical balloon catheter. Fireforce Balloon Inflation Device is designed for rapid and precise control of

inflation process of PTCA/PCI balloon catheter and also can be used in other interventional procedures.

Fireforce Balloon Inflation Device provides consistent pressure output in positive pressure and quick release features. It allows physician to control balloon dilatation process safe and precise. Clear pressure gauge panel allows physician easily to read and monitor in the clinical environment.

## **First Patient Successfully Treated In MicroPort's Castor Implant Clinical Trial**

April 8th, 2013 -- The first patient in China has been implanted with MicroPort Endovascular next generation of thoracic abdominal aneurysm (TAA) stent graft "Castor Branched Aortic Stent Grafts and Delivery System" in the second Military Medical University-Changhai Hospital. The successful first implant again demonstrated MicroPort's commitment to improving patient quality of life through continuous innovation in minimally invasive technology.

In the recent years, there is an increased atherosclerosis incidence of arterial dilation. The presence of limb visceral ischemia, paraplegia and other serious complications will lead directly to disability and fatality. The existing endovascular stent-graft repair has significantly reduced surgical trauma and has gradually become the main treatment for aortic dilatation disease. However, because of its lack of suitable graft endovascular exclusion, the surgery involving left subclavian artery (LSA) is a relative contraindication for endovascular treatment. The advent of Castor makes an invaluable alternative and is a crucial step towards the aortic arch atherosclerosis treatment.

The clinical trials of Castor stent-graft system is the world's first prospective, randomized, multi-center clinical study designed to support State Food and Drug Administration regulatory approval for Branched

Thoracic Stent Graft. It is also an important part of National 863 Projects and the 12th Five-Year Plan. The successful first implant again demonstrates Company's commitment to bringing meaningful innovations to market that provide more treatment options to a broader spectrum of patients.
